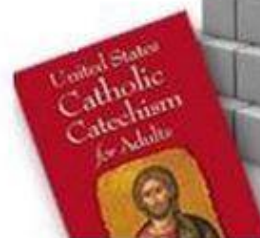

Application Period for Child Sales Tax Rebate

Under [2017 Wisconsin Act 367](#), households will receive a \$100 rebate for Wisconsin

sales and use tax paid on purchases made for raising a qualified child in 2017. Eligible individuals can apply for the rebate beginning May 15 through July 2, 2018, if they have a dependent child who was under the age of 18 on December 31, 2017. Wisconsin Institutes Sales Tax Holiday

Also as a result of [2017 Wisconsin Act 367](#), Wisconsin will recognize a Sales Tax Holiday beginning on August 1 through August 5, 2018. During the holiday, identified items will be temporarily exempt from Wisconsin sales and use tax.
